Tami Baldinger is the founding CEO of the Jewish Women's Foundation of the Greater Palm Beaches, a dynamic, forward thinking, and inclusive grant-making and advocacy social change organization dedicated to gender equality and improving the lives of women and girls. She is deeply committed to Jewish community, the continuity of the Jewish People, and the State of Israel, and creating a more just and equitable society for all. Tami has worked professionally as an attorney and as an advocate for the rights of women and girls and for the State of Israel, and she has held numerous senior leadership volunteer positions in Jewish and communal organizations. She has a BA *cum laude* in history from the University of Pennsylvania and a JD with honors from the George Washington University School of Law.

He was chargé d'affaires (Deputy Ambassador) at the Israeli Embassy in Luanda, Angola, and assistant spokesman to Foreign Minister Shimon Peres.



As the CEO of InterfaithFamily, and a second generation interfaith family member herself, **Jodi Bromberg** is passionate about creating comfortable spaces for interfaith families in Jewish life. Jodi has written extensively on the topic, including for eJewish Philanthropy, the Jewish Journal, the Philadelphia Jewish Exponent and the Jewish Daily Forward's now-defunct Seesaw column. 
